An amendment is proposed to modify our CDBG-NR grant contract to include a revision to the work plan activity completion dates. The project has been bid and construction is underway. We anticipate completing the work well before May 2013 which is the current work plan completion date as of amendment #1. The revised completion date for construction activities as proposed by this amendment request is November 2012.

No other changes are proposed. We are on schedule to spend \$125,000 in local funds for this project. The grant end date remains unchanged at 6/20/13. The grant application score as approved by amendment #1 remains unchanged. There are no changes in the number of beneficiaries, accomplishments or the service area map. All met needs and all future needs as described in the grant application will be addressed.

We have reviewed the Environmental Review Record for this CDBG funded project and have determined that there will be no significant impact to the environment as a result of your approval of this proposed amendment.
