**HISTORY/FACTS/ISSUES:**

Following the approval of the referendum, the BOCC on November 23, 2004 (in compliance with FS. 125.0104(4)) named the people to serve in the statutorily required categories per statute as shown below as "Original Appointees".

The statute states that the members of the committee shall serve for staggered terms of 4 years and the terms are prescribed for each sector in the original resolution that was adopted on November 23, 2004. The statute states that the members must meet the qualifications for the sector they are serving in. Appointed members can be replaced by the BOCC at any time to serve out the remainder of the sector appointees term, which has occurred in the past and is also represented in the table below.
