HISTORY/FACTS/ISSUES:

Sumter County entered into an Independent Contractor Agreement on December 14, 2010 for the transportation and disposal of large off-road and construction tires, loaded in a 40 cubic yard container supplied by the County, from the Sumter County Solid Waste Facility in Lake Panasoffkee, Florida to Omni Landfill in St. Cloud, Florida. This Agreement was for an initial term of one year set to expire on December 13, 2011, and contained a provision granting the County the option to renew the contract for two (2) additional terms of one (1) year each. The County wishes to exercise this renewal option under the same terms and conditions as the initial term.

EXTENSION AGREEMENT

This agreement is made and entered into this _____ day of _____, 2011, between SUMTER COUNTY, FLORIDA, (County) and WASTE SERVICES OF FLORIDA, INC., (Contractor).

WHEREAS, the parties executed an agreement dated December 14, 2010 for the transportation and disposal of large off-road and construction tires, which was for an initial term of 1 year set to expire on December 13, 2011, and which contained a provision granting the County the option to renew the contract for two (2) additional terms of one (1) year each, and

WHEREAS, the County desires to exercise this renewal option at this time under the same terms and conditions as the initial term.

NOW, THEREFORE, the parties agree as follows:

1. That certain Agreement between the parties dated December 14, 2010, is hereby extended to December 13, 2012, on the same terms and conditions as the initial term.
2. No other terms or conditions of said agreement are affected in any way by this extension.
