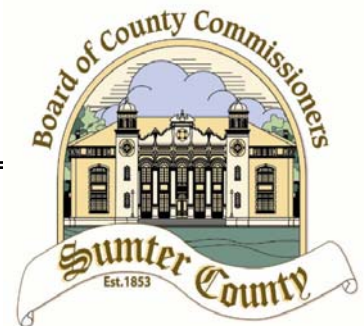

A critical review of previously submitted reports identified several accounting errors. These errors were due to posting of some data in incorrect reporting fields and due to the addition of animals acquired from the close of one reporting period to the beginning of the next. New procedures have been implemented to eliminate these reporting gaps.
