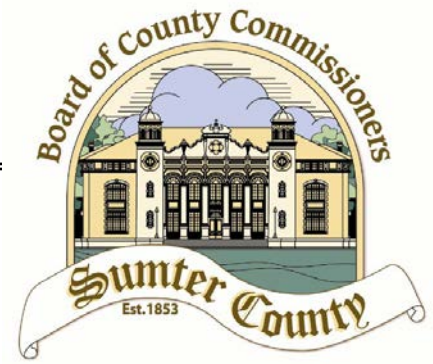

The monthly statistical report for November 2015 states there were 49 other animals as death in kennel. All 49 of those animals were chickens seized from a cruelty investigation case in which they died as a result of being extremely emaciated and neglected.

The report also states 128 other animals were euthanized, of which 127 were chickens from the same investigation. Due to the severe conditions and for the welfare of the animals, the 127 chickens remaining were humanely euthanized per the recommendation of the veterinarian.

This case has been submitted to the State Attorney's Office for review and action as they deem appropriate.
